DIVISIONS: MRPA B & MRPA C

- FORMAT: Six game guarantee. Round robin format (pool play – 2 games to 21). The top teams advance to a single elimination championship series (best 2 out of 3 games).
- WHERE: Apple Valley Community Center, 14603 Hayes Road (952-953-2300). Matches will be on both hardwood floor and sport court floor.
- TIME: Matches are tentatively scheduled to begin at 9:00 a.m., with championship play beginning early afternoon. **Captains will be contacted on Thursday, January 25 with their first match time.**
- ENTRY FEE: \$110 – Make check payable to “MRPF.”
- DEADLINE: **Monday, January 22 at 12 noon.** *Returning teams from 2006 tournament will receive priority, provided they register by Thursday, January 18.*
- RULES: MRPA rules will be followed, with modifications. **Rally scoring will be used & let serves allowed.** Rules and roster will be emailed to the captain upon registration. A brief captain’s meeting will take place 30 minutes prior to start. Matches will be officiated by certified referees.
- AWARDS: Restaurant Gift Cards (\$30 & \$20) and t-shirts will be awarded for 1st and 2nd place finishers. **Shirts are donated by Earl F. Andersen, Inc; they are a recreation equipment supplier.**
- LIMIT: Registration is limited to 24 teams between the two divisions. Based on the number of entries, the tourney director reserves the right to alter the format, divisions, and/or awards.
